Deadline for Submitting Ballot	Ballots must be received, regardless of post-mark date, by the Election Board no later than 4:30pm. Any ballot received after Election Day, regardless of post-mark date, will be invalid. The ballot will be counted "invalid" as part of the reconciliation process.
Terms:	2010 General Elections are to fill the following terms: All terms of office start on first Friday in January to maintain the consistency of the staggered terms of office, whether or not the elected official took oath of office in January. <ol style="list-style-type: none"> 1. Cammie Carrigan 3 year term 2. Nancy A. DeCoteau 3 year term 3. James D. Roberts 3 year term
	The Voter Registration Form provides the Election Board with an eligible voter's current address, date of birth and signature. All tribal members must have a Voter Registration Form on file with the Election Board in order to be sent a ballot. Voter Registration Forms do not need to be submitted ever year and will remain on file with the election board for succeeding years' elections. However, in the event a voter moves, an updated Voter Registration Form must be submitted to ensure the voter receives his or her ballot by mail at the correct address. In order for the voter to receive a ballot by mail, any new or revised registration form must be received by the Election Board no later than <u>November 9, 2010</u> . A Voter may also register at the Administration Building, on <u>December 1, 2010 Election Day</u> and receive a ballot at that time. A Voter may also register at the Administration Building, on <u>November 6, 2010 General Membership Meeting</u> and receive a ballot at that time.
Candidates	Candidacy Applications Forms must be received regardless of post-mark date by the Election Board no later than 4:30 pm on <u>October 1, 2010</u> .
Voter' List	Look for your name on the voter list. If your name is not on the list but you are eligible to vote only you can appeal to the Sauk-Suiattle Tribal Council. Submit a written appeal to Janice W. Mabee, Chairman Sauk-Suiattle Tribal Council no later than <u>NOON, November 3, 2010</u> .
Eligible Voter's	It is the responsibility of the voter to advise the Election Board of his or her
