Page (11) Article 6. Candidacy,  
Section 6/01

- (1) In Order to be a candidate in the election, an individual must be at the time of filing Candidacy Application form:
  - a. An enrolled Member of the Sauk-Suiattle Indian Tribe; and
  - b. At least 21 years of age.
- (2) Disqualify criteria for candidacy:
  - a. No member of the Election Board shall be eligible to be a candidate in the current election, even if that individual shall resign from the Election Board prior to Election Day.
  - b. No member of the Sauk-Suiattle Trust Corporation shall be eligible to be a candidate in the current election (see SSIT Trust Corporate Charter).

Section 6.02 Application

- (1) In order to declare intent to be a candidate, an individual must submit (via mail or hand deliver) a signed, notarized, Candidacy Application Form (available at the Tribal Administration Office) to the Election Board at the following Address:

- (2) The Candidacy Application form will contain a statement that the candidate declares, by signing the Form, that he or she does not hold membership in another tribe. The Candidacy Application Form will also contain a statement that the candidate authorizes, by signing the Application For, the Enrollment Clerk to disclose all relevant information relating to verification of enrollment and date of birth.
- (3) Candidacy Application forms must be received, regardless of post-mark date, by the Election Board no later than 4:30 p.m. on the date of Candidacy Application Deadline, which shall be established by the Election Board on the Election Calendar, and which shall be no earlier than fourteen calendar days after the mailing and posting of the Election Notice Packet and no later than eighteen calendar days before the first Friday in November.
